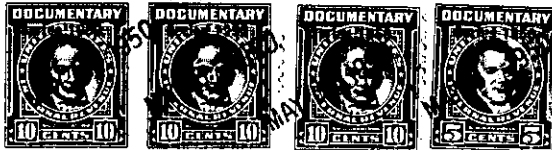

Turner and Ruby P. Turner, their heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Northwest side of Grove Road in that area recently annexed to the City of Greenville in Greenville County, S. C., being shown as Lot 8 and a portion of Lot 7 of Block E, on Plat of Grove Park made by W. J. Riddle, Surveyor, April 1939, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "J", pages 68 and 69, and having according to a recent survey made by Piedmont Engineering Service, February 26, 1948, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Grove Road, said pin being in the center of Brushy Creek, and running thence along the Northwest side of Grove Road N. 49-31 E. 98.8 feet to an iron pin; thence N. 51-41 W. 129.4 feet to an iron pin on the line of Lot 9; thence along the line of Lot 9 S. 36-32 W. 119.9 feet to a point in the center of Brushy Creek; thence down said creek (the traverse line being S. 60-36 E. 109.3 feet) to a point in center of Brushy Creek on Northwest side of Grove Road, the beginning corner.

This is a portion of that lot conveyed to me by deed of Otis P. and James P. Moore, dated January 18, 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 371, at page 1.
