

WALTER C. DUKE AND IRENE M. DUKE

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near the City of Greenville,
Greenville County, South Carolina, and being more particularly described as Lot. 108, Section B, as shown on a plat entitled "A
Subdivision for Woodside Mills, Greenville, S. C.", made by Pickell & Pickell, Engineers, Greenville, S. C., January 14, 1950, and re-
corded in the R. M. C. Office for Greenville County in Plat Book W, at pages 111-117, inclusive. According to said plat the within
described lot is also known as No. 3 MAM Street (Avenue) and fonts thereon 57.5 feet.

The grantor and its predecessors in title have granted unto Patker Water & Sewer Sub-District Commission. Commissioners of Public Works of the City of Greenville S. C., Greater Greenville Sewer District Commission, Greenville Traction Company, Duke Power Company and Southern Public Works of the Power Company and Southern Public Utilities Company. Concertee Mills, Southern Bell Telephone and Telegraph Company, Southern Railway Company, and Prediment and Northern Railway Company, and its predecessor Greenville. Spartanturg and Anderson Railway Company, to one or more of them and/or to there all water and sweer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sever lines), valves, littings, hydrants, manholes, poles, wires, transformers, regulators, and other appearants and equipment used in connection with, or forming a part of the water, it is predeceded together with rights of way and easements to go, upon the land for the purpose of maintenance, repair, alteration, replacement, construction, reduction, and operation including meter residing) of the lines and systems aforesaid and oceration other railroad, water, sewer, electric, telephone, street trolley, and power lines constructed or to be constructed, and to velocate certain of ruch lines so as to run them in, along, above or near the streets and alleyways and power lines constructed or to be constructed, and to velocate certain of ruch lines as a relocated, all as will more fully appear by reference to the records in the R. There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described, and this conveyance is made subject to the rights of way and easements above mentioned insofar and the many many affect said lot.

This conveyance is made subject to the following restrictions:

- (1) That no mercantile establishment, other than those already in existence, shall be erected, operated or maintained on the lot above described.
- (2) That only one residence shall be erected or maintained on any one lot.
