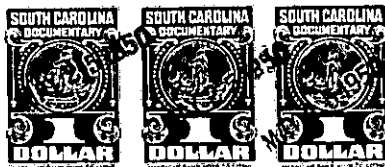

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Homer S. Balentine, Jr., his heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 100, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

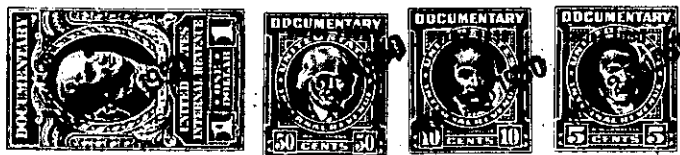
BEGINNING at an iron pin on the northern side of Bradley Boulevard at the joint front corner of lot Nos. 100 and 101 and running thence with the joint line of said lots N37-34W 182.5 feet to an iron pin, joint rear corner of lot Nos. 100 and 114; thence with joint line of said lots N52-26E 75 feet to an iron pin, joint corner of lot Nos. 99, 100, 114 and 115; thence with joint line of lots 99 and 100 S37-34E 182.5 feet to an iron pin on the northern side of Bradley Boulevard; thence with Bradley Boulevard S52-26W 75 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
