

ALSO all my one-half undivided interest in and to all that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, in Paris Mountain Township, being known as a portion of the Paris Mountain-Caesar's Head Development Company, lying on the Northeast side of Altamont Road, as shown on plat of Paris Mountain-Caesar's Head Company, prepared by A. C., being known and designated as Lot No. 36 and part of Lot No. 35 of Section B on plat made by R. E. Dalton, Engineer, June, 1925, and having, according to a recent survey made by R. E. Dalton, 1939, the following metes and bounds, to-wit:

BEGINNING at a concrete monument on the West side of Lake Circle Road at the Northeast corner of property of the grantor and grantee herein, and running thence with line of property now belonging to the grantor and grantee, N. 75-05 W. 242 feet to a concrete monument; thence still with the line of property of the grantor and grantee N. 12-20 W. 307 feet to a concrete monument; thence N. 86-40 E. 421 feet to an iron pin on the West side of Lake Circle Road; thence with the West side of said Road, S. 16-40 W. 395 feet to the beginning corner, and containing 2.50 acres.
