all that piece, parcel or lot of land in -----Greenville----- Township. Greenville-----County. State of South Carolina , on Berkley Avenue between North Franklin Road and Darlington Avenue, in the Sans Youci section of Greenville County, about three miles north of the city of Greenville, said lot having the following lines, courses and distances, to wit:-

Beginning at an iron pin on the southern edge of a five (5) foot sidewalk running along Berkley Avenue, said pin being the joint front corner of lots numbered twenty-two (22) and twenty-three (23); and running thence with the southern edge of said sidewalk, S. 80-52 E., sixty (60) feet, to an iron pin, joint front corner of lots twenty-one (21) and twenty-two (22); thence with the western line of lot twenty-one (21), S. 9-08 W., one hundred and thirty-three and four tenths (133.4) feet, to an iron pin, joint rear corner of said lots twenty-one (21) and twenty-two (22); thence along the rear line of lot twentysix (26), N. 80-03 W., sixty (60) feet, to an iron pin, joint rear corner of lots twenty-two (22) and twenty-three (23); thence along the eastern line of lot twenty-three (23), N. 9-08 E., one hundred and thirty-two and five tenths (132.5) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered twenty-two (22) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "R" at page 127, which Plat is hereby referred to and made a part hereof.

Said property is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a . period of twenty-five (25) years from the date hereof:-
