Greenville County, S. C., in deed Book 412, page 149, and further subject to utility easements of record.

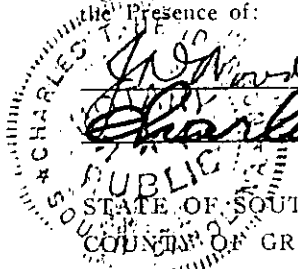

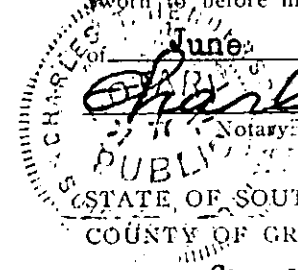

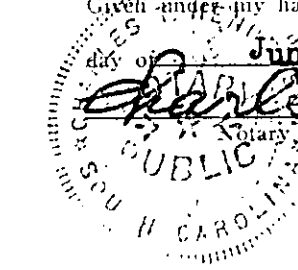
