A. Dewey Turner and 3.7. Waters, Sr. to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A.

Dewey Turner and B.B. Waters, Sr., their heirs and assigns: All of that parcel or tract of land situate and being in Highland Township of Greenville County, South Carolina, lying on both sides of Middle Tyger River and on the West side of a road that leads from the Cockerel Bridge to Gowansville, in Gowansville School District 14-D, and, also lying on both sides of a surface-treated road which leads from the Cockerel Eridge Road near the High place into State Highway No. 14 at the old McLain farm, containing One Hundred Forty-three and 17/100 (143.17) acres, more or less, bounded on the North by lands of Oma Morrow and T.B. Barton Estate lands, on the Mast by lands now owned by High, on the South by A.J. Reves, and on the West by lands of Frank Reid.

The above described land is the homestead of the late Philemon Turner, and is composed of that tract conveyed to him by U.D. Morrow by deed dated February 7, 1913, recorded in the R.M.C. Office for Greenville County in Deed Pook No. 24, at page 260, and a part of that tract conveyed to him by S.J. Douthit, Probate Judge, by deed dated Oct. 4, 1869, recorded in Deed Book HH, at page 463, in said R.M.C. Office, the remainder of the last tract having been conveyed by Philemon Turner to Jefferson Parton in 1886.

The grantors herein are the sole devisees (surviving) of the late Philemon Turner and the heirs at law of Raywond E. Turner, the said Raymond E. Turner being one of the devisees under the will of Philemon Turner and having died intestate leaving his widow, Ida Bentley Turner and one child Ellen Turner Breeback. The widow of Philemon Turner, Ida F. Turner, died during the year 1942.
