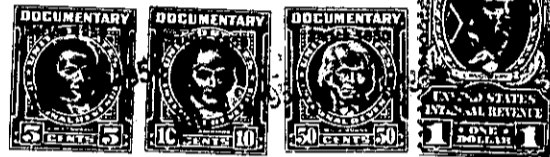

That T. C. STONE, HARRIET M. STONE, INDIVIDUALLY AND AS TRUSTEE/ in the State aforesaid, in consideration of the sum of FIFTEEN HUNDRED FORTY (\$1500.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said F. E. ALBRIGHT and LOLA K. ALBRIGHT, their Heirs and Assigns:

All that certain piece, parcel or lot of land, situate, lying and being on the Western side of Broughton Drive in a subdivision known as Croftstone Acres, being known and designated as Lot No. 9, Section G, of said subdivision, and being described according to a plat of Croftstone Acres prepared by C. B. Dawsey, Engineer, dated August, 1946, and recorded in the RMC Office for Greenville County, S. C., in Plat Book "S" at pages 78 and 79, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Western side of Broughton Drive at the joint front corner of Lots Nos. 9 and 10, Section G, and running thence along the common line of said lots in a Westerly direction, 267.7 feet to a point, the joint corner of Lots Nos. 9, 10, 19 and 20, Section G; thence along the common line of Lots Nos. 9 and 20 in a Southeasterly direction 75 feet to a point, the joint corner of Lots Nos. 8, 9, 20 and 21, Section G; thence along the common line of Lots Nos. 8 and 9 in a Southeasterly direction 258.5 feet to a point on the Western side of Broughton Drive; thence along the Western side of Broughton Drive, N. 2-50 W. 87 feet to the beginning corner.

Grantees agree to pay taxes for the year 1950.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
