Know All Men by These Presents:

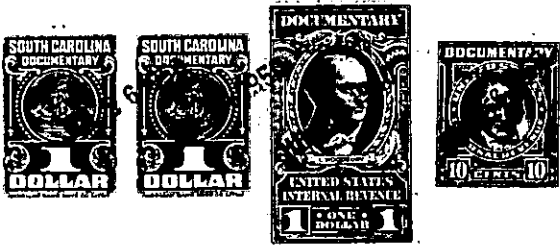

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. B. Willis, Jr., his heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on Irene Circle, near the City of Greenville, and being shown as lot No. 21 on plat of Royal Heights made by Dalton & Neves in April 1949, and recorded in Plat Book W at Page 25, and described as follows:

BEGINNING at a stake on the Western side of Irene Circle at corner of lot No. 15 and running thence with the lines of lots 15, 16 and 17 and 18, N. 63-53 W. 175.5 feet to a stake at corner of lot 25; thence with the line of said lot, N. 26-07 E. 75 feet to a stake at corner of lot No. 22; thence with the line of said lot, S. 63-53 E. 131 feet to a stake on Irene Circle; thence with the Western side of Irene Circle, S. 4-39 E. 87.1 feet to the beginning corner.
