RENUNCIATION OF DOWER

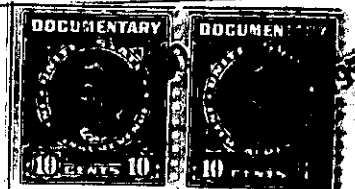
