Houck in consideration of the sum of Eight Hundred and No/100- - - - - (\$800.00) DOLLARS, and assumption of mortgage set out below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. C. Bates, his Heirs and Assigns forever,

All that piece, parcel or lot of land in Greenville County, Greenville Township, State of South Carolina, between North Franklin Road and Darlington Avenue, in the Sans Souci Section of Greenville County, about three miles North of the City of Greenville, said lot having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern edge of a 5-foot sidewalk running along Berkley Avenue, said pin being the joint front corner of Lots Nos. 22 and 23; and running thence with the Southern side of said sidewalk, S. 80-52 E. 60 feet to an iron pin, joint front corner of Lots Nos. 21 and 22; thence with the Western line of Lot No. 21, S. 9-08 W. 133.4 feet to an iron pin, joint rear corner of Lots Nos. 21 and 22; thence along the rear line of Lot No. 26, N. 80-03 W. 60 feet to an iron pin, joint rear corner of Lots Nos. 22 and 23; thence along the eastern line of Lot No. 23, N. 9-08 E. 132.5 feet to an iron pin, the beginning corner.
