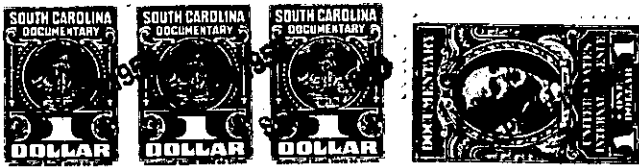

Know All Men by These Presents:

That I, F. H. Hill in consideration of the sum of fourteen hundred and no/100

in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said F. C. Bates

All that piece, parcel or lot of land in Greenville County, State of South Carolina, being known as Lot No. 2 according to plat of property of Frank H. Hill made by C. C. Jones, Egr., dated April, 1948, revised September, 1950, being on the east side of Buncombe Road, and having, according to said plat, the following metes and bounds:

Beginning at a point in the center of the Buncombe Highway at corner of other property of the grantor and running thence in a northeasterly direction 50 feet to an iron pin at corner of other property of the grantor and on highway right of way; thence N. 63-36 E. 184.7 feet to an iron pin; thence S. 25-55 E. 7 feet, more or less, to an iron pin; thence N. 62-25 E. 113.1 feet to an iron pin; thence N. 11-44 W. 104.5 feet to an iron pin; thence along line of Lot No. 1, S. 67-43 W. 352.1 feet to an iron pin on the highway right of way; thence in a southwesterly direction 50 feet to a point in the center of said highway; thence along the center of said highway, S. 38-57 E. 125 feet to the point of beginning.

This property is conveyed subject to the following restriction:

(1) Said property shall be used exclusively for white residential purposes.

The above described property is conveyed subject to the right of way of the Highway Department that extends 100 feet in an easterly direction from the center of said highway, including the Highway Department beautification right of way as shown on said plat.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
