in consideration of the sum of Six Hundred Fifty and no/100 - - - - - DOLLARS,

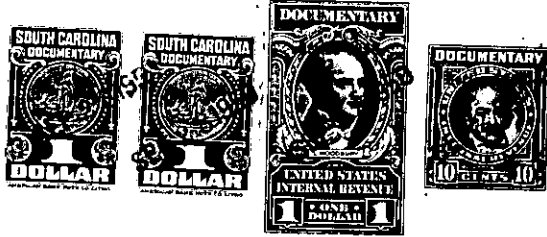
