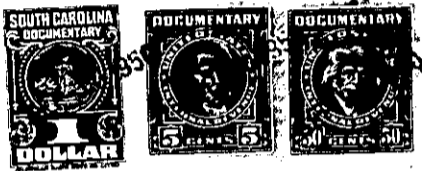

All those lots of land in Chick Springs Township, Greenville County, State of South Carolina, on the western side of Sutton Drive, being shown as lots Nos. 22 and 23, of Block D, on Plat of Buena Vista Subdivision, recorded in Plat Book W at Pages 11 and 29, and having according to said plat the following metes and bounds, to-wit:
