

C., Greater Greenville, Sewer District Commission, Paris Mountain Water Company, and Duke Power Company, to one or more of them and for to others all water and sewer pipe lines (other than house lines), electric light and power lines, including all pipe (other than house water and sewer lines), valves, fittings, hydrants, manholes, poles, wires, transformers, regulators, and other apparatus and equipment used in connection with, or forming a part of, the water, fire protection, electric light and power distribution, and sewerage systems of the F. W.
