All that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, and in Oaklawn Township, about one and one-fourth miles from Woodville on the road leading from the Old Hundred School House toward Sandy Springs School House, containing 139.75 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the edge of the road at the corner of property now or formerly belonging to Mrs. Mamie Tollett, and running thence along the line of her property, S. 63 3/4 W. 16.73 chains to post oak 3xom; thence N. 36-30 W. 2.50 chains to a stone 3x; thence S. 70 W. 21.72 chains to a stake 3x; thence S. 24-30 W. 12.40 chains to a maple 3x; thence S.  $46\frac{1}{2}$  E. 35.58 chains to a stone 3xom; thence N.  $63\frac{1}{2}$  E. .73 links to a stake 3xom; thence N. 15 W. 3.80 chains to a stake on branch; thence down said branch to creek; thence down said branch to the mouth and down the creek, 7.32 chains to a stake on the south bank of said creek; thence N. 22-37 E. 23.93 chains to a stake 3x; thence S. 62 E. 15.65 chains to an iron pin in the middle of a cross road; thence along said road, N. 30 E. 3.80 chains to an iron pin in the center of cross road; thence along the center of road, N. 30 W. 24.40 chains to an iron pin; thence continuing along the center of said road, N. 30-30 W. 5.52 chains to the beginning corner.
