Know All Men by These Presents:

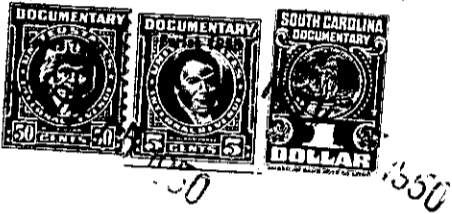

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), has (have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. B. Willis, Jr., herein called grantee, Lot 80 as shown on plat of Sans Souci property of J. P. Rosamond by Dalton & Neves, dated April, 1931, recorded in Plat Book H at Page 186. From this plat the following description is taken:

BEGINNING at a point on the western side of W. Decatur Street which is the joint front corner of Lots 80 and 81, and running thence their joint line N. 83-45 W. 175.6' to their joint rear corner; thence the rear line of Lot 80 which is the line between this property and that of Union Bleachery S. 11-05 E. 62.8' to the joint rear corner of Lots 79 and 80; thence the joint line between these lots S. 83-45 E. 157' to their joint front corner on W. Decatur Street; thence along the western edge of said street N. 6-15 E. 60' to the beginning corner.

The property above described is located near the City of Greenville, in Greenville County, State of South Carolina in that section known as Sans Souci.
