to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Barbara K. Counts, her heirs and assigns, all that piece, parcel or lot of land situate, lying and being on the Easterly side of Brookside Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #13, Subdivision of Overbrook Land Company, Tract #1, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "J", page 81, and having, according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the Easterly side of Brookside Avenue, joint corner Lots #12 and #13, which iron pin is 157.5 feet in a Southeasterly direction from an iron pin in the Southeast intersection of Overbrook Road and Brookside Avenue, and running thence N. 72-11 E. 201.2 feet to an iron pin in the rear line of Lot #9; thence S. 44-30 E. 16.9 feet to an iron pin, joint rear corner Lots #13 and #14; thence S. 45-30 W. 180 feet to an iron pin on the Easterly side of Brookside Avenue; thence along the Easterly side of Brookside Avenue N. 44-30 W. 107.1 feet to an iron pin, the point of beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

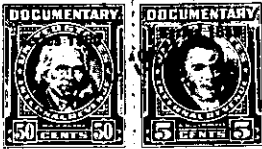
