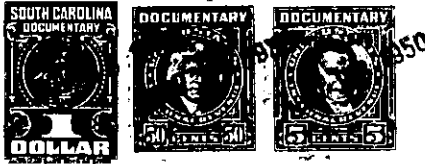

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said B. M. Thomasson and Bessie M. Thomasson, their heirs and assigns forever;

ALL that piece, parcel or lot of land being known and designated as Lot No. 219 of Pine Forrest as shown by a Plat thereof, made by Madison H. Woodward, Engineer, said Lot having the courses, distances, metes and bounds to-wit:

BEGINNING at an iron pin on corner of Lot No. 218 and running thence along said Lot N. 41-10 E. 252.5 feet to an iron pin; thence S. 73-45 W. 111.5 feet to iron pin at corner of Lot No. 220; thence along the line of Lot No. 220 S. 41-10 W. 158.7 feet to iron pin on street; thence along said street S. 48-50 E. 60 feet to point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence to cost less than Two Thousand (\$2,000.00) Dollars shall be erected on said lot, and no residence shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.

THIS deed is made subject to the easements, reservations and limitations that are set forth in the deed of the Grantor herein, to Blackinton Mills, Inc., recorded in the R. M. C. Office for Greenville County, S. C., in Book of Deeds 288 at Page 296.
