to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

A. M. Mikell

All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 126 according to a plat of University Heights, plat made by Piedmont Engineering Service, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book Y, Page 53, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Buena Vista Street at the joint front corner of Lots Nos. 125 and 126 and running thence along the line of Lot No. 125, N. 24-04 W. 198 feet to an iron pin; thence S. 59-0 W. 85 feet to an iron pin in the rear line of Lot No. 16; thence along the rear line of Lot No. 16 and 17, S. 20-12 E. 200 feet to an iron pin on the north side of Buena Vista Street; thence along the northern side of Buena Vista Street, N. 58-10 E. 100 feet to an iron pin at the point of beginning.

The above described property is subject to the following restrictions:

- (1) The property shall be used for residential purposes only.
- (2) No house shall be constructed on the premises at a cost of less than \$8,500.
- (3) The lot described above is not to be re-cut or re-subdivided.
- (4) Any construction on the lot shall be set back a distance of 50 feet from the front line.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

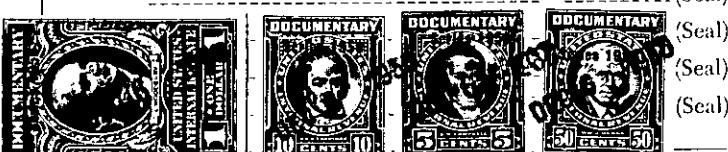
