to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ruth Bates Adams, her Heirs and Assigns forever,

All that piece, parcel or lot of land in Greenville County, State of South Carolina, on the West side of Washington Avenue, being known and designated as Lot No. 1 as shown on Plat of property of L. O. Patterson, Trustee, prepared by Dalton & Neves, Engineers, in April 1942, recorded in Plat Book K at Page 128, and being more particularly described according to said Plat as follows:

BEGINNING at an iron pin on the Western side of Washington Avenue at corner of Lot shown on said Plat as the Remus Rouda lot, and running thence S. 80-13 W. 244 feet to an iron pin, rear corner of Lot No. 18; thence with the rear line of said lot, N. 3-55 W. 38.3 feet to the joint rear corner of Lots Nos. 1 and 2; thence with the joint line of said lots, N. 75-07 E. 228 feet to an iron pin on the Western side of Washington Avenue; thence with said Avenue, S. 22-00 E. 60 feet to the beginning corner.
