

County, State of South Carolina, on Skyland Drive between the New Buncombe Road and the Tindal Road, in the Sans Souci Heights Sub-Division on the New Buncombe Road about four miles north of the City of Greenville, said lot having the following lines courses and distances:-

Beginning at an iron pin on the northern edge of a three (3) foot sidewalk running along Skyland Drive, said pin being the joint front corner of lots numbered forty-six (46) and forty-seven (47); thence along the northern edge of said sidewalk, S. 67-40 W., eighty-three and eight tenths (83.8) feet, to an iron pin, joint front corner of lots forty-five (45) and forty-six (46); thence along the eastern line of lot forty-five (45), N. 26-43 W., one hundred and forty and eight tenths (140.8) feet, to an iron pin, joint rear corner of lots forty-five (45) and forty-six (46); thence along the rear lines of lots thirty-three (33) and thirty-four (34), N. 60-20 E., sixty-six (66) feet, to an iron pin, joint reaf corner of lots forty-six (46) and forty-seven (47); thence along the western line of lot forty-seven (47), S. 33-25 E., one hundred and fifty and five tenths (150.5) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered forty-six (46) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "W" at page 155, which Plat is hereby referred to and made a part hereof.

Said property is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of twenty-five (25) years from the date hereof:-
