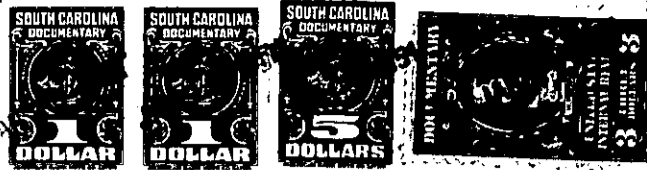

Know All Men by These Presents:

That I, Rodney M. Piper in the State aforesaid,  
in consideration of the sum of three thousand three hundred twenty-five and no/100 DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. L. Scott, his heirs and assigns forever

All that certain piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, known and designated as the eastern portion of Lot No. 89 of the subdivision known as Forest Heights, according to a plat of the same of record in the R. M. C. Office for Greenville County in Plat Book "P", at page 71 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of East Paris Road at the northwest corner of Lot No. 90 and running thence along the line of Lot No. 90, S. 21-09 E. 297.9 feet, more or less, to an iron pin; thence S. 63-45 W. 414.1 feet to pin; thence N. 17-04 E. 496.5 feet to pin on the south side of East Paris Road; thence along the south side of said road S. 71-03 E. 14.5 feet; thence still along said road S. 83-38 E. 107.2 feet; thence still with said road N. 72-29 E. 40 feet to the beginning corner, being a portion of the same lot of land conveyed to the grantor herein by H. S. Sellers and Ollie C. Sellers by deed dated March 16, 1950 and of record in the R. M. C. Office for Greenville County in Deed Book 405, at page 173.

This conveyance is subject to the easement along the rear line of said lot as shown on the plat above referred to and likewise, subject to the conditions and restrictions set out on the instrument of record in the R. M. C. Office for Greenville County in Volume 297, at page 256.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
