Williams and Edith D. Williams, their heirs and assigns, forever:

All that certain piece, parcel or lot of land on the East side of Mellon Street, in the Village of S. Slater & Sons, Inc., at Slater, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 21 of Block G, as shown on a plat of the Village of S. Slater & Sons, Inc., made by J. E. Sirrine & Company, Engineers on July 10, 1940, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book K at pages 63, 64 and 65 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Mellon Street at joint front corner of Lots 20 and 21 and running thence with the line of Lot 20 of Block G, N. 87-24 E. 125 feet to an iron pin; thence along the rear line of Lot 7, S. 2-37 E. 70 feet to an iron; thence with the line of Lot 22, S. 87-24 W. 125 feet to an iron pin on the East side of Mellon Street; thence with the East side of Mellon Street, N. 2-37 W. 70 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

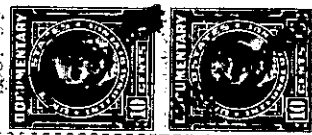
