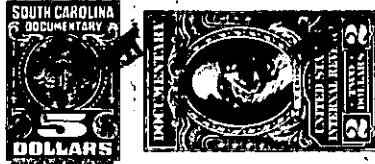

Know All Men by These Presents:

That C. P. Clanton, Jr. in the State aforesaid, in consideration of the sum of Twenty-two Hundred and No/100 (\$2200.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lena Turner Jennings, her heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the East side of Batesview Drive in that area recently annexed to the City of Greenville, in the County of Greenville, S. C., being shown as Lot No. 17 on Plat of Property of Corinne Bates, made by P. B. Wilson, Surveyor, November, 1945, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book "S", page 183 (also recorded in Plat Book "Y", page 53) and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Batesview Drive at joint front corner of Lots 16 and 17 and running thence in an Easterly direction along the line of Lot 16 298.2 feet to an iron pin; thence S. 20-12 E. 110 feet to an iron pin on the North side of Beuna Vista Street; thence along the North side of Beuna Vista Street in a Westerly direction 332.3 feet more or less to an iron pin at the Northeast corner of the intersection of Batesview Drive and Beuna Vista Street; thence with the East side of Batesview Drive N. 5-25 W. 109 feet to the beginning corner.

Being the identical property conveyed to C. P. Clanton, Jr. by deed of William T. Bates, dated April 26, 1950, recorded in the R.M.C. Office for Greenville County, S. C. in Deed Book 408, page 473.

For restrictions applicable to the above property see deed mentioned above from William to Bates to C. P. Clanton, Jr., recorded in Deed Book 408, page 473.
