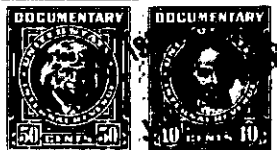

Charles G. Moore and Jewell R. Moore, their heirs and assigns, forever,

ALL that piece, parcel or lot of land in Chick Springs Township, Greenville
County, State of South Carolina, Being known and designated as lots number
14 and 15 on plat of property of G. D. Collier made by H. S. Brockman on May
21, 1947, and recorded in the R. M. C. Office for Greenville County in Plat
Book "R" at page 21, and taken together, having the following metes and bounds,
to wit:

BEGINNING at a point on the South side of Dan Street, joint corner of lots
number 13 and 14, and running thence with line of lot number 13 S. 12-00 W.
65.6 feet to a point; thence S. 81-30 E. 147 feet to a point on Pauline Street;
thence with Pauline Street N. 15-00 W. 70.5 feet to the intersection of Dan
Street; thence with Dan Street N. 80-00 W. 115 feet to the beginning corner.

and their Heirs and Assigns forever.

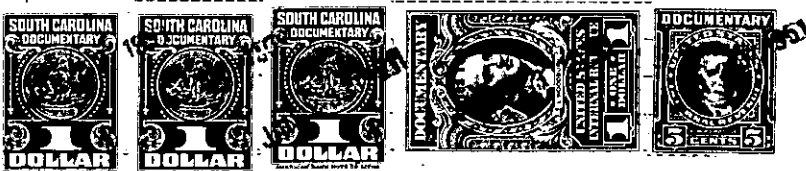
And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant
