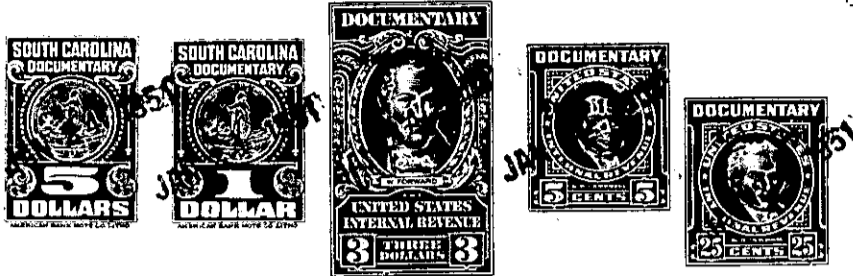

presents do grant, bargain, sell and release unto the said...Robert Otis Solesbee, Jr. and Gladys  
V. Solesbee, Their Heirs and Assigns forever,

all that piece, parcel or lot of land in O'Neal Township, Greenville  
County, State of South Carolina Near Washington Baptist Church, on the west side of  
State Highway No. 14, leading from Greer, S. C. to Landrum, S. C. about five  
miles North from Greer, and having the following courses and distances to wit:-

BEGINNING at an iron pin on the North bank of road that leads from said  
h ghway to Gap Creed road, said iron pin being near old shop building, and runs  
thence with a farm road as follows; N. 55-44 W. 100 feet to an iron pin in  
ditch of said road; thence N 71-20 W. 100 feet to an iron pin in ditch; thence  
N. 65-35 W. 194.7 feet to an iron pin in edge of said road; thence S/ 11-05 E.  
179.8 feet to an iron pin on terrace bank; thence S. 67-58 E 268.5 feet to an  
iron pin inthe first named road; thence N. 33-11 E. 130.5 feet to the beginning  
corner and containing One and nine-one hundredths (1.09) acres, more or less,  
this being all of the same lot of land conveyed to me by DEED of Frances Haney  
dated April 19th., 1947. Said DEED recorded in R. M. C. Office for Greenville  
County in Vol. 310, page 428.
