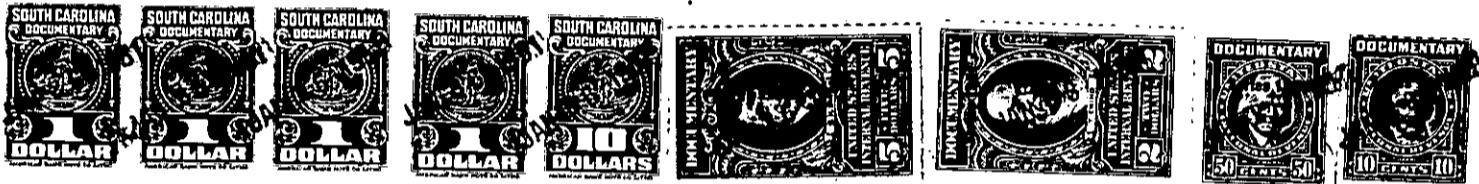
That I, Donald E. Baltz in the State aforesaid,

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the city of Greenville, Butler Township, county of Greenville, state of South Carolina, being known and designated as lot No. 63 on plat of College Heights made by Dalton & Neves, Engineers, August 1946, recorded in the R. M. C. Office for Greenville County in plat book "P" page 75 and having according to a more recent survey made January 1951, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the north side of Columbia Circle, the joint corner of lots No. 62 & 63 which pin is 375 feet west from the northwest corner of the intersection of Columbia Circle and Griffin Drive, and running thence with the joint line of said lots N. 33-10 W. 175 feet to an iron pin corner of lot No. 51; thence with the rear line of lot No. 51, S. 56-50 W. 75 feet to an iron pin corner of lot No. 64; thence with the line of said lot S. 33-10 E. 175 feet to an iron pin on the north side of Columbia Circle; thence with the north side of said street N. 56-50 E. 75 feet to the beginning corner.

This property is conveyed subject to the restrictive covenants and building restrictions applicable to College Heights subdivision.
