and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged
and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN,
Master in and for the County aforesaid, to Louisa M. Redfearn
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Preesents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree,
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Louisa M. Redfearn, all the right, title and interest of the Defendants, in and to the following described real estate:
"All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Southeast side of East Pinehurst Drive, in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 18 on plat of property of Helen M. Powe, made by W. J. Riddle, Surveyor, June, 1944, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "P", at Page 65, and having, according to said plat, the

BEGINAING at an iron pin on the southeast edge of East Pinchurst Drive, at joint front corner of Lots 17 and 18, and running thence along the line of Lot 17, S. 1-15 W. 192 feet to an iron pin; thence S. 89-52 E. 54.6 feet to an iron pin; thence N. 14-05 E. 220.8 feet to an iron pin; thence N. 89-52 W. 95 feet to an iron pin on East Pinchurst Drive; thence along East Pinchurst Drive in a Southwesterly direction following a curved line 21 feet, more or less, to the beginning corner."

The consideration for the above conveyance was the sum of \$1687.88 in cash paid by Louisa M. Redfearn individually to herself as Administratrix
