All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the city of Greenville, Butler Township, county of Greenville, state of South Carolina, being known and designated as lot No. 66 on plat of College Heights made by Dalton & Neves, Engineers, August, 1946 recorded in the R. M. C. Office for Greenville County in plat book "P" at page 75 and having according to said plat the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the south side of Columbia Circle, joint corner of lots No. 65 & 66, which pin is 141 feet east from the southeast corner of the intersection of Columbia Circle and a 20 foot road, and running thence with the joint line of said lots S. 33-10 E. 150 feet to an iron pin in line of lot No. 76; thence with the rear line of lots No. 76 & 75, N. 56-50 E. 75 feet to an iron pin corner of lot No. 67; thence with the line of said lot N. 33-10 W. 150 feet to an iron pin on the south side of Columbia Circle; thence with the south side of said street S. 56-50 W. 75 feet to the beginning corner.
