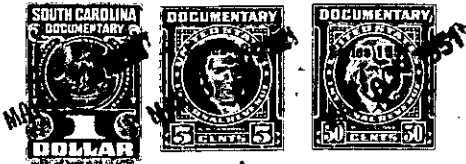

Highway No. 86 in the Town of Piedmont, County of Greenville, State of South Carolina, as shown on a plat thereof entitled "Property of Piedmont Mfg. Co." made by Dalton & Neves, December, 1950, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at the intersection of Main Street and S. C.
