

Brown, their heirs and assigns, for ever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being at the Southeast corner of the intersection of Third Avenue and Coodrich Street near the City of Creenville, in the County of Greenville, State of South Carolina, being shown as Lot No. 1, Section 1, on plat of Judson Mills No. 1, made by Dalton & Neves, Engineers, August 1939, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book K, at pages 11 and 12, and having according to said plat the following metes and counts, to-wit:

BECINIES at an iron pin at the Southeast corner of the intersection of Third avenue and Coodrich Street, and running thence with Third avenue, S. 1-30 W. 95 feet to an iron pin, joint front corner of Lots 1 and 2; thence with the line of Lot 2, S. 85-30 E. 128.4 feet to an iron pin on the Southwest side of Goodrich Street; thence with Goodrich Street, N. 49-02 W. 159.6 feet to the beginning corner.
