Know All Men by These Presents:

That I, Emily T. Purdum, in consideration of the sum of Ten and no/100 (\$10.00) Dollars and other valuable considerations

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. W. Dalton, his heirs and assigns:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being situate on the Westerly side of Trail's End, within the limits of the City of Greenville, South Carolina, being known and designated as Lot No. 163, per plat of Cleveland Forest prepared by Dalton and Neves in May, 1940, as recorded in R. M. C. Office for Greenville County, S. C., in Plat Book M, page 137, having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Trail's End at joint front corner of Lots Nos. 163 and 164, said pin being 130 feet Northwest of iron pin in the Northwest corner of the intersection of Trail's End with Knollwood Lane; thence along the joint line of said lots, S. 64-35 W. 159.8 feet to an iron pin at joint rear corner of Lots Nos. 163 and 164; thence N. 22-25 W. 65 feet to an iron pin at joint rear corner Lots Nos. 163 and 162; thence N. 64-35 E. 159.8 feet to an iron pin at the joint front corner of Lots Nos. 163 and 162 on the Westerly side of Trail's End; thence along said Trail's End, S. 25-25 E. 65 feet to an iron pin at joint front corner of Lots Nos. 163 and 164, the point of beginning.

The herein grantee is to pay the 1951 taxes on the above described property.

The above described property is subject to restrictions recorded in the R. M. C. Office for Greenville County, South Carolina, in Vol. K, at pages 47 and 90. Said property is further restricted in that no residential building shall be built thereon costing less than \$6,000.00, nor nearer than 50 feet to the street line. Any residential building built on said lot shall face onto Trail's End.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

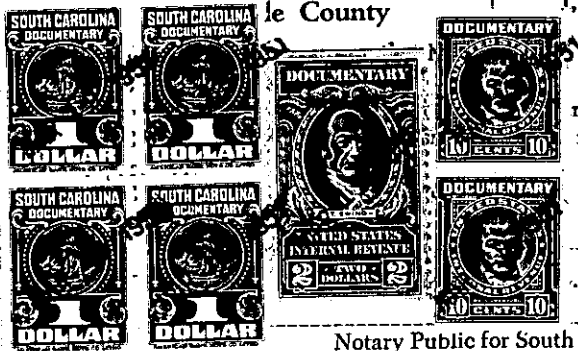
