to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Paul Allen Bridges,

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the city of Greenville, Butler Township, county of Greenville, state of South Carolina, being known and designated as lot No. 67 on plat of College Heights made by Dalton & Neves, Engineers, August, 1946 recorded in the R. M. C. Office for Greenville County in plat book "P" at page 75 and having according to said plat the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the south side of Columbia Circle, the joint corner of lots No. 67 & 68, which pin is 225 feet west from the southwest corner of Columbia Circle and Griffin Drive, and running thence with the joint line of said lots S. 33-10 E. 150 feet to an iron pin in line of lot No. 74; thence with the rear line of lots No. 74 & 75, S. 56-50 W. 75 feet to an iron pin corner of lot No. 66; thence with the line of said lot N. 33-10 W. 150 feet to an iron pin on the south side of Columbia Circle; thence with the south side of said street N. 56-50 E. 75 feet to the beginning corner.

This property is conveyed subject to the restrictive covenants and building restrictions applicable to College Heights subdivision.
