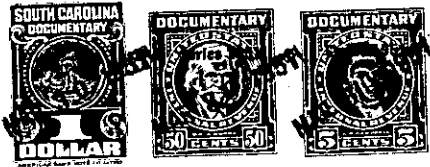
Know All Men by These Presents:

B. Willis, Jr., herein called grantee, Lot 84 as shown on plat of the property of J. P. Rosamond, by Dalton & Neves, April 1931, recorded in Plat Book H at Page 186, from which the following description is taken:

BEGINNING at a point on the western edge of W. Decatur Street, joint front corner of Lots 83 and 84, and running thence their joint line N. 83-45 W. 231.5' to their joint rear corner in line of Union Bleachery; thence that line N. 11-05 W. 62.8' to the joint rear line of Lots 84 and 85; thence running the joint line between these lots S. 83-45 E. 250.1' to their joint front corner on the western edge of W. Decatur Street; thence running said edge of this street S. 6-15 W. 60' to the point of beginning.

The above property is located near the City of Greenville, in Greenville County, South Carolina.
