(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these pres-  
ents do grant, bargain, sell and release unto the said William R. Woods

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, at the intersection of Broughton Drive and Wedgewood Avenue in a Subdivision known as Croftstone Acres, being known and designated as Lot No. 9, Section C (as revised) as shown on a plat entitled "Partial Revision of Croftstone Acres, Greenville, S. C." prepared by J. C. Hill, land surveyor, dated February 26, 1951, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book T at page 311 and having according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Western side of Broughton Drive at the joint front corner of Lots Nos. 9 and 10, Section C and running thence along the common line of said lots S. 77-23 W. 236.4 feet to an iron pin; thence N. 07-18 W. 40 feet to an iron pin on the Southern side of Wedgewood Avenue; thence along the Southern side of Wedgewood Avenue N. 63-10 E. 230 feet to an iron pin at the intersection of Wedgewood Avenue and Broughton Drive; thence along Wedgewood Avenue and Broughton Drive as the two converge S. 57-26 E. 32.3 feet to an iron pin; thence continuing along the Western side of Broughton Drive S. 2-06 E. 74.8 feet to an iron pin, the beginning corner.

By deed dated October 18, 1948 and recorded in the R. M. C. Office for Greenville County, South Carolina in Deed Volume 362 at page 352 the grantors herein conveyed unto the within named grantee certain property more specifically described in said deed as a portion of Lot No. 9, Section C of Croftstone Acres. Subsequent to the execution of the aforementioned deed, a revision of a portion of Croftstone Acres was made and a plat showing said revision recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book T at page 311. A number of property owners in Croftstone Acres Subdivision desire to re-locate their lot lines so as to conform with the partial revision of Croftstone Acres as shown on the aforementioned revised plat and in order to accomplish said purpose, the grantee herein along with certain other property owners in Croftstone Acres Subdivision reconveyed unto the grantors herein the property heretofore conveyed to them and this conveyance is made in furtherance of the agreement to re-locate said properties in order to conform with the partial revision of Croftstone Acres as shown on the aforementioned recorded revised plat.
