(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these pres-
ents do grant hargain sell and release unto the said Hazel W. Houseman:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina at the intersection of Broughton Drive and U. S. Alternate Highway No. 29 in a Subdivision known as Croftstone Acres, being known and designated as Lot No. 15 of Section C of a revised portion of Croftstone Acres as shown on a plat recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "T" at page 311 and having according to said plat the following metes and bounds, courses and distances to-wit:

BLGINNING at an iron pin on the Northern side of U.S. Alternate Highway No. 29 at the joint corner of Lot No. 15, Section C, and a lot designated on the aforementioned plat as "Sold" and running thence along the common line of said lots N. 2-50 W. 200 feet to an iron pin in the Southern line of Lot No. 14, Section C; thence along the common line of Lots Nos. 14 and 15, Section C S. 84-37 E. 117.4 feet to an iron pin on the Western side of Broughton Drive; thence along the Western side of Broughton Drive S. 2-06 E. 155 feet to an iron pin at the Northwestern corner of the intersection of U. S. Alternate Highway No. 29 and Broughton Drive; thence along the Northern side of U. S. Alternate Highway No. 29 S. 72-54 W. 119.3 feet to an iron pin the beginning corner.

The Grantee agrees to pay taxes for the year 1951.

The parties hereto agree that as part of the consideration for this conveyance the following restrictive covenants shall apply to the above described property; that said covenants shall run with the land and shall be binding on the parties hereto, their heirs and assigns forever:

- 1. The above described property shall be used for residential purposes only.
- 2. No building shall be erected, placed or altered on the above described lot until the building plans, specifications, and plot plan showing the location of such building have been approved in writing as to conformity, and harmony of external design with existing structures in the Subdivision, and as to location of the bullding with respect to topography and finished ground elevations, by the grantors herein, in the event the grantors herein fail to approve or disapprove such design and location within thirty days after said plans and specifications have been submitted to them, or in any event, if no suit to enjoin the erection of such building or the making of such alterations has been commenced prior to the completion thereof, such approval will not be required and this covenant will be deemed to have been fully complied with.
