

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Calvin V. O'Brient and Clarice N. O'Brient, their heirs and assigns, forever:

All that certain piece, parcel or lot of l'and situate, lying and being on the West side of East Faris Road in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 84 on plat of Forest Heights made by Dalton & Neves, Engineers, June 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book P, page 71, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of East Faris Road, joint front corner of Lots 83 and 84, and running thence along the line of Lot 83, N. 84-42 W. 241.8 feet to an iron pin; thence S. 26-00 E. 114 feet to an iron pin; thence with the line of Lot 85, S. 89-49 E. 195 feet to an iron pin on the West side of East Faris Road; thence along the West side of East Faris Road following the curve thereof (the chord being N. 3-44 W. 80 feet) to the beginning corner.
