All that certain lot of land in Greenville County, Greenville Township, State of South Carolina, being known and designated as Lot No. 72, according to a plat of the property of Sans Souci Development Company, plat made by Dalton & Neves, Engineers, July, 1930, and recorded in the R.M.C. Office for Greenville County in Plat Book h, at Pages 185 and 186, and having the following metes and bounds to-wit:

BEGINNING at an iron pin on the southeastern side of East Decatur Street at the joint front corner of Lot Nos. 71 and 72 and running thence along the line of Lot No. 71, S. 30-54 E. 212 feet to an iron pin at the rear corner of Lot No. 71; thence S. 73-12 W. 75 feet to an iron pin at the rear corner of Lot No. 73; thence along the line of Lot No. 73, N. 27-03 W. 191 feet to an iron pin on the southeastern side of East Decatur Street, joint front corner of Lots Nos. 72 and 73; thence along the southeastern side of East Decatur Street, N. 55-57 E. 60 feet to an iron pin at the point of beginning.
