All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina. ten feet in width, and marked "alley" on Plat of the Property of Daisy Lee Potts, recorded in Plat Book U at Page 138, which is described as follows:

BEGINNING at an iron pin on the Southern side of Summitt Avenue at the corner of John R.
