All that piece, parcel or lot of land in Saluda Township, Greenville County, State of South Carolina, lying on the south west side of U. S. Highway No. 25 (Greenville-Hendersonville Road) about 12 miles south of the North Carolina South Carolina boundary line, and being a part of the property commonly known as "Chestnut Springs" the same being shown and designated on a plat of the property of D. F. Hughey, plat made by H. L. Dunahoo, surveyor, and dated April 25-27, 1951, said plat to be recorded in the R. K. C. office for Greenville County, and having the following courses and distances according to said plat, to wit:
