That I, Henry P. Willimon in the State aforesaid,
in consideration of the sum of Seven Hundred & 00/100-----(\$700.00)-----DOLLARS,

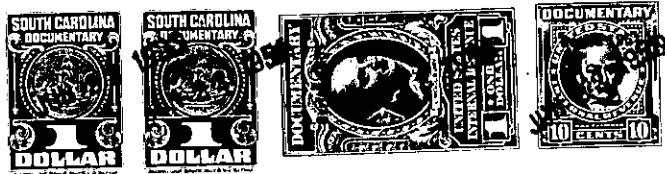
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. W. Todd and Ruby Todd, their heirs and assigns forever;

ALL that piece, pareel or lot of land being known and designated as Lots Nos. 230 and 231 of Pine Lake Circle as shown by a Plat thereof, made by Madison H. Woodward Engineer; said lots having the courses, distances metes and bounds to-wit:

BEGINNING at an iron pin at corner of Lot No. 229 and running thence along the line of said Lot No. 229 N. 67-41 W. 121.5 feet to back corner of Lot No. 229; thence S. 26-39 W. 120.5 feet to back corner of Lot No. 232; thence along the line of said Lot No. 232, S. 67-41 E. 130.8 feet to iron pin on street; thence along the line of said street N. 22-19 E. 120 feet to point of beginning.

THAT the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent. No residence to cost less than Two Thousand (\$2,000.00) Dollars shall be erected on said lot, and no residence shall be erected on said lot nearer than twenty five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feetm or more, frontage.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
