

Beginning at an iron pin on the eastern edge of a three (3) foot sidewalk running along Christopher Street, said pin being the joint corner of lots fourteen (14) and fifteen (15), and the Burnett lot facing Dukeland Drive; thence along the rear line of the Burnett lot, N. 55-55 E., one hundred and fifty (150) feet, to an iron pin, joint rear corner of lot fifteen (15) and the Burnett lot; thence S. 20-06 E., sixty-four and four tenths (64.4) feet, to an iron pin in line of lot twelve (12); thence S. 80-26 W., six and eight tenths (6.8) feet, to an iron pin, rear corner of lot fourteen; thence along the line of lot twelve (12), 3. 9-29 E., one hundred (100) feet, to an iron pin, rear line of lots facing McMakin Drive; thence S. 80-26 W., one hundred and twenty-three and seven tenths (123.7) feet to an iron pin on the eastern edge of said sidewalk running along Christopher Street; thence along the eastern edge of said sidewalk, N. 20-06 W., one hundred and two and four tenths (102.4) feet, to an iron pin, the beginning corner, said lot being known and designated as lots numbered thirteen (13), fourteen (14) and fifteen (15), on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "S" at page 49, which Plat is hereby referred to and made a part hereof.
