BEGINNING at an iron pin on the East side of Elizabeth Drive at the rear corner of Lot No.: 101, and running thence with the rear line of Lots No. 101 and 100, N. 72-52 E. 200 feet to an iron pin; thence S. 33-30 E. 75 feet to an iron pin at the rear corner of Lot No. 214; thence with the line of said lot, S. 56-30 W. 214.9 feet to an iron pin on Elizabeth Drive; thence with the Eastern side of Elizabeth Drive, N. 23-14 W. 133 feet to the point of beginning.

It is understood that this conveyance is made subject to the following restrictions, which are expressly made a part of the consideration thereof, and that the same are for the benefit of the Grantor, Grantees, and all other persons owning lots shown on said Plat above mentioned: Said lots shall be used exclusively for residential purposes.
