All that certain piece, parcel or lot of land, situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, designated as lots # 26, 27, and 28 on a plat of property of Greenville Motor Boat Club, Inc., said plat being recorded in the R. M. C. Office for Greenville County in Plat Book Y at page 21, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin at the South West corner of the intersection of Club Circle and Scout Road, and running thence S. 28-35 W. 113.5 feet to an iron pin; thence S. 31-29 W. 113 feet to an iron pin; thence N. 70-26 W. 168 feet to an iron pin at the highwater mark of the Saluda River; thence along the highwater mark of the said Saluda River in a northeastern direction 87 feet, more or less, to an iron pin; thence still along the highwater mark of said River in a Northwestern direction 135 feet, more or less, to an iron pin; thence in a northeastern direction 81 feet, more or less, to an iron pin on the South side of Club Circle; thence along Club Circle S. 59-57 E. 181 feet to an iron pin; thence S. 70-00 E. 120 feet to an iron pin at the point of beginning.
