Ayers, as shown on plat made by R. K. Campbell, April 24, 1949, and recorded in the R. M. C. Office for Greenville County in Plat Book W, page 27, and having the following metes and bounds:

BEGINNING at an iron pin on the west side of Tiffany Drive, at corner of Lot No. 9, and running thence with line of Lot No. 9, S. 68-03 E. 194.1 feet to iron pin at joint corner of Lots Nos. 9, 10, 39 and 40; thence with the rear line of Lot No. 39, S. 24-34 E. 70 feet to an iron pin at joint corner of Lots Nos. 10, 11, 38 and 39; thence with line of Lot No. 11, N. 68-05 E. 190.2 feet to iron pin on Tiffany Drive; and thence with the west side of Tiffany Drive N. 22-57 W. 70 feet to the beginning corner, being a portion of the same conveyed to me by Martha J. This property is conveyed subject to the following restrictions and conditions: Said property to be used for residential purposes only; no residence to cost less than \$5,000.00; no building to be erected nearer than 30 feet from the street on which it faces; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no part of said property to be sold, rented or otherwise disposed of to any person of African descent; property conveyed subject to recorded rights-of-way; no residence to be built on any lot or portion thereof, unless said lot has 50 feet or more street frontage.
