That I, Clois D. Poole in the State aforesaid, in consideration of the sum of Six Hundred and No/100- (\$600.00) DOLLARS,

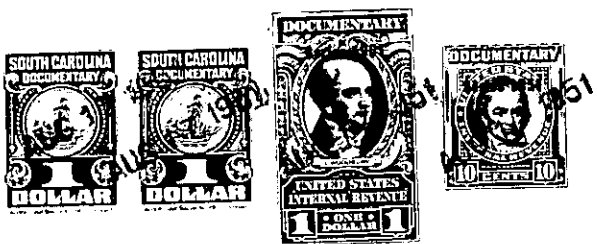
