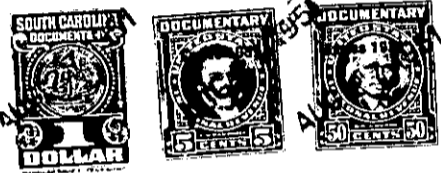
Know All Men by These Presents:

That We, P. L. Bruce, Nora B. Bruce and Thomas S. Bruce, in the State aforesaid, in consideration of the sum of Three Hundred Twenty-five (\$325.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Willie Robinson, his heirs and assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State aforesaid, being known and designated as Lot No. 4 according to a plat of property of P. L. Bruce prepared by R. K. Campbell, April, 1950, recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book W, page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At a point on the Northwest side of an unnamed street, joint front corner of Lots Nos. 3 and 4, and running thence along the Northwest side of said unnamed street, S. 34-55 W. 60 feet to a point on the Northwest side of said unnamed street, joint front corner of Lots 4 and 5; thence along the joint line of Lots 4 and 5, N. 55-05 W., 140 feet to a point, joint rear corner of Lots Nos. 4, 5, 23 and 24; thence along the joint rear line of Lots 4 and 24, N. 34-55 E, 60 feet to a point, joint rear corner of Lots 3, 4, 24 and 25; thence along the joining line of Lots Nos. 4 and 3, S. 55-05 E. 140 feet to a point on the Northwest side of said unnamed street, the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do hereby bind the grantor(s) and the grantor's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's Heirs and Assigns against the grantor(s) and the grantor's Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
