21. This agreement cancels and supersedes as of July 16, 1951 that certain "Lease Agreement" dated July 12, 1949 between the parties hereto, covering property located on the northeast side of the Mostella Road, one half mile north of Greer, South Carolina.

22. Should the option contained in paragraph two of article two above, be exercised for the period therein provided, then and in that event this lease shall automaticly renew itself from year to year thereafter, on the same terms and conditions, subject to the right of either party to terminate this lease at the expiration of any yearly period, by giving the other party thinky (30) days' written notice, prior to the expiration of the period then in effect.
