of One (1) year(t) each, on the same covenants and conditions as herein provided, each of which options Shell may exercise by giving Lessor notice at least forty-five (45) days prior to the expiration of the original term or the then-current extension period, as the case may be. If Shell does not exercise its then-current option to extend, the term shall be automatically extended from year to year, on the same covenants and conditions as herein provided, unless and until either Lessor or Shell terminates this lease at the end of the original term or the then-current extension period or any subsequent year, by giving the other at least thirty (30) days' notice.

Third.

Shell shall pay, as rent for the leased premises, a sum equal to one and one half cents cent(s, l2 ¢) for each gallon of gasoline sold upon the leased premises by Shell or its sublessee or licensee during each calendar month during the term of this lease, payable, in cash to, or by check to the order of, J. M. and SARA W. GRIFFIN

on or before the fifteenth day of the succeeding calendar month; provided, however, that the rent for any calendar month shall
